Dear Friend in the Community,

The Southminster Presbyterian Church Foundation was created by members of our Church. Its purpose is to provide support for the work of the church and the important work of non-profit organizations within our community.

Each year the Foundation provides limited grants to various non-profit organizations. The Southminster Foundation is eager to hear from non-profit organizations that are furthering our congregation's vision of a community that is peaceful, healthy, and economically and socially just. The Foundation seeks to support non-profit organizations that are in communities surrounding Southminster Presbyterian Church.

The Foundation is seeking granting opportunities with a specific, tangible benefit, and opportunities to help leverage lasting changes in people's lives. We are particularly interested in addressing issues associated with housing, food, poverty, domestic violence, and medical care in response to social and racial justice matters.

Foundation guidelines for approving grants:

- * Priority is given to applications from non-profits geographically close to Southminster Presbyterian Church. International grants are specifically precluded.
- * Priority areas for funding are: 1. Direct services or goods 2. Facilities/equipment 3. Staff
- * Grants are made for a single year and are rarely approved for more than two consecutive years to a single organization.
- * Funds are designated for the specific purpose for which the request was made or as agreed upon between the Foundation and the grantee.
- * Please note that, in practice, the grant amounts are almost always less than \$3,000.

The grant application, review, and approval process:

- * Grant applications are due February 28th, 2025 and PDF format copies are highly preferred
- * The Foundation considers the applications in March, and may request a site visit to find out more about your organization and the grant request, sometime during March or April.
- * Decisions and announcement regarding grant awards are usually made by the end of May 2025.
- * All grant applicants are then notified of the decisions by the Foundation, and successful grantees will receive a check for the funds awarded.

Award grantees will be asked to provide a brief quarterly report to the Grant Committee explaining their progress using the grant funds, and listing their expenditures.

- * Grantees who have received grant funds for two consecutive years must wait a year before applying again.
